Notice to the Public: How to Submit Public Comments. The Board of Directors' meetings are open to the public. At special or emergency meetings, members of the public may only address the District on items listed on the agenda. Anyone wishing to submit written information for a future meeting is requested to provide ten (10) copies to the Board Secretary in advance to facilitate distribution. Providing multiple copies is voluntary, and all members of the public retain the right to submit materials regardless of the number of copies provided. Willful disruption of the meeting shall not be permitted. If the Chairperson finds that someone is, in fact, causing willful disruption of any meeting, they may order the disrupting parties out of the room and then conduct the District's business without them present.
